Reporting to the President and CEO, the **Vice-President**, **Operations** (VPO) is responsible for overseeing fishery activities throughout FFMC's supply region and operational leadership of FFMC's Winnipeg processing plant. Responsibility for the plant in Winnipeg includes all processing operations, quality assurance, purchasing and health and safety. The VPO plays a key role in collaborating with the senior leadership team in developing FFMC's strategic direction and future.

Key Responsibilities

- Full responsibility for and proactively lead Plant Management and Field Operations organizations in developing, implementing, and achieving corporate goals and objectives.
- Identify and implement strategies, technologies, and process improvements to enhance operational performance.
- Provide regular status and corrective actions on fishery and plant operations, including financial management, processing yields, product quality, fish deliveries and labour efficiency.
- Insure compliance with all government and regulatory requirements.
- Maintain strong relationships with represented employees and union leadership and participate in negotiating collective agreements.
- Develop and maintain relationships with fishers, agents and other external stakeholders in Western Canada based on trust, accountability, open communication, and decisive action.

- I0 years of leadership experience in a senior manufacturing/operations role; food processing is an asset.
- Strong leadership experience, including building and developing diverse teams and managing collective agreements.
